144.18. Apologies for absence.

145.18. Minutes

The minutes dated Monday 3rd September 2018 were accepted as a correct record and duly signed by the chair.

146.18. Update on items from last meeting. Not reported separately.

- **Mobile Signal.** Cllr Taylor reported that no one has responded to volunteer to gather data on mobile coverage, which was very disappointing. Data provided by Ofcom and the network operators says there is signal in Dedham (not necessarily strong, and not by all providers). Without specific data we are unable to apply pressure on the network/service providers to provide a better service. A call for volunteers will be posted on Facebook. Cllr Beeton, Cllr. Herbert, Cllr. Taylor and Brian Hindley will look to take this forward (GDPR). Scope- centre of the village.
- Club refurbishment. Cllr Baker gave this report under Item 150.
- WW 1 Commemoration Event. Cllr Frost reported that the programme is set. The Bakery Café will be making the refreshments. The Assembly Rooms has been hired at a reduced rate for a charitable event, whose costs will be met by Peter King (Kingsleigh residential)
- Local Highways Panel. The Clerk reported that the land acquisition required to install a section of footway to join Crown Street to Manningtree Road, would include the brick wall at Hallfields House. The Environment Group will look at any other possible solutions.

Highways have made a mess of the hedge cutting on the entrance of South Fields. When they strimmed the edge of the Brook, it went into the Brook. The Brook is also in a poor condition. These issues will be picked up by the Environment Group.

Demolition of existing old timber and tin sheds, stores, and stable, and replacement with new timber sheds, store, and stable.

182171.Mill Lane, Welcome to Colchester' sign.

Recommendation: Planning and policy issues. Planning is on hold until certain aspects are addressed. As it stands, Dedham Parish Council with the planning application as its stands. We are not at all content with a sign saying welcome to Colchester

Cllr Nigel Chapman has spoken to Martin Goss, portfolio holder, and will be speaking to the zone manager tomorrow.

150.18. Duchy Field Rent Increase request from Dedham Church

To discuss a request from Dedham Church for a substantial increase in the rent for the Duchy Field, and to agree a response

This item was withdrawn.

Cllr Baker reported that funding application for the Sports Pavilion has been submitted. This is for the ramp and veranda. The second stage of the work will be done in house (changing room, referee changing etc)

151.18. CBC Staffing and toilets opening times

To receive a report of zone team staffing changes and to discuss and agree opening times for the toilets. Melinda, member of the zone team reported that CBC were operating Mon- Fri, and then a market shift. They are now working 5 days out of 7, 7.30-3.30, not working in specific zones now, and spending a lot of time in the town centre. They are also, currently a reduced team.

DPC will monitor the impact on Dedham.

152.18. Consideration of employment of Community Payback Personnel.

Brian reported that the Probation Service no longer operate this and it is now run by Community Payback. Ideas put forward include: Stratford Road rubbish needs clearing. Cleaning the war memorial. Hedge tidying

153.18. Dogs on the Recreation Ground

Dog Fouling, in Public Places. Dog Fouling can be reported via the CBC website or by telephone to CBC 01206 282581.Or email. customerservices@colchester.gov.uk A Public Space Protection Order (PSPO) was introduced on 31.10.2016 against the antic social behaviour of dog fouling in public areas across the Borough with all locations where the public has permission to access private land and to enable the Council to enforce legislation against dog fouling. Under the legislation dog owners are required to clear up after their dogs in public areas. Failure to do so will result in a fixed penalty charge of £100.00 or a fine in court up to £1,000.00

Melinda, the zone teams can enforce dog fouling, has suggested host an anti dog fouling event.

Dogs on Leads.

To discuss the implications of asking people to keep dogs on leads, in the Playing Field, Duchy Field and The Drift and to agree a way forward.

The only legislation in the borough is in Highwoods Country Park, and CBC car parks. There is little that can be done, in terms of enforcement. 'Dogs must be kept under control' signs can be displayed.

154.18 Highways Devolution

The EALC have announced a trial with ECC for devolving some highways services to Parish Councils. The EALC are looking for parishes to trial this scheme. It was resolved to volunteer for the trial. Proposed: Clir Follows Seconded: Clir Beeton Agreed by all
