20.009. Lighting Project- The Drift

Cllr Beeton gave an introduction to the item, and review of the current position.

...

Cllr Follows and Frost explained their reasoning for requesting the rescission, which is largely due to the time constraints of the much larger resurfacing project.

a)To receive a proposal from 2 councillors (Cllrs Follows and Frost), to resolve to rescind the resolution made on 2nd December 2019, item 165.19, stating, '...it was agreed to make provision for a budget of £6000 in principle, to carry out the specification design for The Drift resurfacing scheme, including the lighting element, which is to be a priority.' It is requested that this item be rescinded due to the timescales for the Drift surfacing project being inappropriate for the completion of the lighting scheme.

Proposed: Cllr Follows Seconded: Cllr Frost

6 in favour, 2 against. Carried.

b)To receive a design proposal from a Lighting and Electrical engineer and to review each element and agree, if appropriate. Once agreed, to circulate as the design specification and seek quotes.

Cllr Follows read the proposed specification, based on DPC's original spec which came as a result of the consultation-with amendment/ recommendations made by the Lighting Engineer submitting the design.

Cllr Taylor- raised issues with the original spec, and the new proposed spec, which is not precisely the same. An amended Certificate of Lawfulness will be needed to reflect an increase in the number of lights proposed.

Councillors debated the details of the specification, with particular reference to the use or not of PIR/infra-red sensors; whether the use of this specification of a potential contractor is appropriate; whether a conservation application should be made; the need for an application for a revised certificate of lawfulness; and the desire to complete the project before the end of the council term.

Following a lengthy debate, it was resolved to agree the specification as set out, to seek quotes, and to make a further application for a Certificate of Lawfulness.

4 in favour 4 against. Chairman's casting vote. Agreed. Carried.

Clerk will circulate the quotes and reapply for a certificate of lawfulness.

c)In light of the decision above it was resolved to review the broader project for resurfacing Royal Square and The Drift plus associated costs and so to remove the lighting element. This will be discussed with costings under a closed session at the February meeting.
